2008 Mock Interview/Resume Workshop for Law Students of Color

Dear Colleague:

Practicing Attorneys for Law Students (“PALS®”) invites you to join us for the *Third Annual Mock Interview/Resume Workshop for Law Students of Color* (“Workshop”). The Workshop shall take place on **Tuesday, August 5, 2008**, at 3:00 p.m. followed by a cocktail reception at 5:45 p.m. at the New York City Bar*. This Workshop is designed to help law students of color prepare for the fall recruiting season by identifying characteristics that legal employers look and listen for when interviewing summer associates, interns and clerks. The Workshop will enable participants to engage in mock interviews and receive critical feedback on interviewing skills. There will also be a panel discussion on interviewing skills. Attorney participation begins at 4:30, after the interview skills panel.

For the past two years we have had over 150 students and attorneys participate in the mock interviews. The success of this Workshop will depend on the active support of New York City law firms and corporations. I am writing to ask if you would volunteer several of your firm’s attorneys to conduct the mock interviews and to give your firm the opportunity to underwrite this program as Sponsor (see enclosed pledge form).

Firms are welcome to participate without underwriting the Workshop. Attorney volunteers are encouraged to participate for the 1 ½ hours of interviews. Each interview will last 45 minutes. The mock interview will take place during the first 30 minutes, and the remaining time will be a review of the student's resume, as well as a discussion about strengths and weaknesses observed during the mock interview. Participating law students will come from the 13 New York area law schools.
